UNAIDS will respond in writing (via email only) to any request for clarification of the ITB that it receives prior to the deadline for queries as indicated above. A consolidated document of UNAIDS's response to all questions (including an explanation of the query but without identifying the source of enquiry) will be sent to all prospective bidders who have received the ITB. Questions are to be submitted in the format "Paragraph Number - Question." and it will also be posted in UNAIDS website along with the response.

- 3) Proposals must be received at Email address TechnicalBids@unaids.org <u>no</u> <u>later than 13 April 2015, 17:00 hours, Geneva Time</u>.
- 4) UNAIDS will open the proposals in the presence of a committee formed by UNAIDS at the Headquarters office in Geneva, Switzerland.

Each technical proposal will be opened during the session, and each bidder will be announced. Bidders may wish to attend the session (at their own cost) and should inform UNAIDS in advance via email if they plan to attend. Non-attendance has no implication on the evaluation of the bids.

- 5) At the discretion of UNAIDS, selected bidders may be invited to supply additional information on the contents of their proposal during the evaluation period. Such bidders could be asked to give a presentation of their proposal (possibly with an emphasis on a topic of UNAIDS's choice) followed by a question and answer session. The presentation will be held at UNAIDS by video-conference/Internet, Bidders will be given reasonable time to prepare for the presentation.
- 6) Evaluation of proposals and the selection of a vendor will be performed in accordance with the Invitation to Bid (ITB).
