
#### Context:

The responsibilities of the Communications and Global Advocacy department within UNAIDS includes effectively positioning UNAIDS and our issues with key audiences, and to create, manage and share knowledge with partners and potential partners in the AIDS response.

We work with a multimedia approach including communications, web and social media.

# **Objectives:**

- This Expression of Interest (EOI) is published to identify individuals interested in submitting their offers to a Request for proposals exercise.
- UNAIDS is planning to launch a Request for Proposals (RFP) to identify individuals or organizations to support the Secretariat in defining the strategy to be used in key areas of communication and delivering the final product to the Communications and Global Advocacy department in the areas of support described below during a period of twelve months.
- The contract would cover multiple assignments during the contractual period, where each assignment is expected to be delivered between two to five days from the date it is requested with frequent prioritized interactions and usually a fixed deadline, defined by the nature of the task, agreed to at the beginning of each assignment.
- UNAIDS has estimated a potential volume of work of about 140 assignments during the contractual period. UNAIDS however does not guarantee the volume of work. It is the intention of UNAIDS to award two to three contracts to ensure availability of resources at short notice.
- UNAIDS is striving to deliver around-the-clock communications activities, therefore the ideal service
  provider should be able to deliver services outside of Geneva working hours with some hours
  overlapping for the purposes of coordination.



Following the results of the EOI, a Request for Proposals will be published with refined terms of reference (TOR) based on feedback received in the EOI. Participation in the EOI does not guarantee been eligible for participating in the RFP nor it eliminates other potential bidders from participating in the RFP, however it allows UNAIDS to establish a contact for communicating the launch of the RFP.

### **Areas of Support:**

All deliverables and correspondence will be in English, therefore excellent knowledge of English is required. Advanced level of French is highly desirable and knowledge of other UNAIDS official languages (Russian and Spanish) will be an advantage.

Each assignment will be producing a combination or a single deliverable from the main tasks specified below.

# Press Release, Statement, Fact Sheet, or Update

Develop clear, compelling proactive media outreach materials

# **Media Strategy**

Draft plan addressing context, objectives, tactics, and materials

#### **Reactive Media Relations**

Advise on media strategies and draft messages, Q&As, or quotes in response to breaking news or critical developments (multi-day or ongoing crises would require more time)

# **Story Pitch Ideas**

Brainstorm feature story ideas; draft pitches; identify target reporters/outlets and conduct outreach as appropriate (several story ideas will be generated for each topic or issue)

### **In-Country Executive Support**

Draft/edit briefs and talking points; advise on or draft media strategies and materials; conduct outreach, as needed

#### Reports

Research, write, and edit substantive reports; cost depends on extent of original research, extent of engagement with experts, number of experts involved, review process, rounds of revision, and length

### **Expected qualifications of supplier of services:**

UNAIDS is looking to engage companies or individuals with proven expertise in the provision of communications services in English for international organizations with at least 5 years of experience and formal qualifications to deliver those services. Companies providing more than one individual would be required to explicitly assign individuals so that UNAIDS and track and verify their qualifications and experience.
