What has worked well	<ul> <li>Accessible free ART</li> <li>HIV mainstreaming within the private sector</li> </ul>
Gaps and challenges	<ul> <li>Engagement of the Private sector in HIV service delivery, utilization of stipulated guidelines and reporting needs to be strengthened</li> </ul>
What needs to be done differently	<ul> <li>Local innovation –recognize local manufacturers and provide tax rebates for them</li> <li>Strengthen multi-sectoral coordination that includes Private sector partnerships to leverage on private sector's service provision/outreach country wide.</li> </ul>

What has worked well	• Existence of private sector coordination networks such as Kenya Health Sector Federation (KHF)
Gaps and challenges	Private sector unable to feed in the national grid
What was not done well	Sustainability of programs when donor funding ends
What needs to be done differently	<ul> <li>Strengthen the private sector national coordination networks through linkages with national and county HIV coordination</li> <li>Strengthen accountability/efficiency in HIV program delivery</li> <li>Build capacity of government to engage the private sector and to provide guidance on private sector engagement</li> </ul>

What was not done well	HIV data been coded to international standards	
What needs to be done differently	<ul> <li>To code HIV data in terms of the different kinds of HIV rather than generalizing</li> <li>Scale up engagement of the youth in HIV prevention</li> <li>Systems strengthening within the private sector</li> <li>To bring together the private sector and FBOs within the response</li> <li>To look at what is in it for the private sector since they are there to make some profit – the next strategy to allow flexibility of private sector within the response</li> <li>Dissect policies into manageable bites</li> <li>To mainstream programmes for people with disability in the HIV response</li> <li>To support local manufacturers producing products that are directly or indirectly linked to HIV</li> </ul>	

<ul> <li>To have all arms of government be involved within the response by supporting local manufacturers – regulators to also support local manufacturers to ensure products for HIV are available</li> <li>To strengthen the regulatory system, quality and safety of products related to HIV</li> <li>To think about sustainability of financial models in ensuring that beneficiaries do not lack treatment in future</li> <li>UNAIDS to continue working closer with the private sector</li> <li>To have a national framework for the private sector that will read and engage up to the county level</li> <li>To have a regulatory framework that encourages the private sector in innovation and investment in health sector by strengthening the role of public sector, that provide the regulatory framework that harnesses opportunity within the private sector.</li> <li>UNAIDS to consider human rights and private sector in the next strategy – private sector not willing to engage due to fear of litigation.</li> <li>Kenya Health Federation and family networks are supported in advocacy as a conduit for private sector to ensure there is a mainstreamed agenda for HIV</li> </ul>
