SUMMARY

Ms Takaenzana welcomed the new PCB Bureau Members for 2015; the Vice-Chair of the PCB, the representatives of the PCB NGO Delegation as well as ILO. The chair explained that in view of the compressed timeline for 2015 with the work on the update and extension of the UNAIDS Strategy 2016-2021 and the shorter timeframe between the two PCB meetings (June and October), the Bureau will discuss the possible agenda items for both PCB meetings to enable the most effective allocation of items.

On behalf of UNAIDS, Ms. Beagle, welcomed the new PCB Bureau members. She requested an additional point to be added under any other business: The 2015 ECOSOC resolution on the Joint Programme.

After adoption of the agenda, the Secretariat presented the possible agenda items for the 36th and 37th Programme Coordinating Board meetings, which will be held in Geneva respectively from 30 June-2 July and 26-28 October 2015. The presentation of the proposed agenda items for the two Board meetings in 2015 was based on the enclosed annex.

1. Preparation for the 36th and the 37th PCB meetings

UNAIDS Secretariat explained the content of the table of possible items for the 2015 PCB Meetings (in annex) capturing all decision points and specific requests made by the PCB at previous PCB meetings. The table was used to inform the discussion of Bureau members on agenda items for the 36th and 37th PCB meetings. The Secretariat first presented the possible agenda items for the 36th PCB meeting and Bureau decided as follows:

36th PCB meeting

- UNAIDS Secretariat Staff Association (USSA) report: <u>Confirmed</u> for the 36th PCB meeting.
- Follow-up to the Thematic Segment: "Halving HIV transmission among people who inject drugs": Confirmed for the 36th PCB meeting. The Bureau confirmed that the Secretariat will provide a summary report from the debate which will be cleared by the Bureau in accordance with usual practice.

The Secretariat recalled the process to prepare the thematic segment. The call to express interest in being part of the PCB working Group to prepare the thematic day will be sent shortly and the first meeting of the Working Group held on the third week of March.

The Chair requested UNAIDS Secretariat to prepare the draft annotated agenda of the 36th PCB meeting based on the agreed agenda items. The final approval of the draft annotated agenda will be done electronically prior to the next meeting of the Bureau.

37th PCB meeting

The Secretariat presented the possible agenda items for the 37th PCB meeting and Bureau decided as follows:

- Report of the 36th PCB meeting: Confirmed for the 37th PCB meeting.
- **EXD report**: Confirmed for the 37th PCB meeting.

The Secretariat will send the call to express interest in being part of the PCB working Group to prepare the thematic day during the first week of June 2015 and we would have the meetings of the PCB Working Group, will be held in July-August.

Requests with no timeframe

The Secretariat presented the requests from the PCB with no timeframe and Bureau decided as follows:

Decision point 6.8 from the 34th PCB meeting: Recognizing the contribution of young people through the full programme cycle and within decision-making processes requests UNAIDS to develop indicators to monitor youth participation within the AIDS response.

Bureau agreed that UNAIDS Secretariat would continue its work with the relevant partners to define indicators for the participation of young people for the updated Strategy and UBRAF 2016-2021.

- [Report by the NGO representative]
 Decision point 4.1 from the 35th PCB meeting; Requests the Joint Programme, working with relevant partners, to produce a synthesis report of existing research and literature on intellectual property (IP)-related and other factors impacting the availability, affordability, and accessibility of treatment and diagnostics for HIV and co-infections in low and middle-income countries, including the following provisions in articles 71a and b of the 2011 Political Declaration, which state:
 - a. The use, to the full, of existing flexibilities under the Agreement on Trade-Related Aspects of Intellectual Property Rights specifically geared to promoting access to and trade in medicines, and, while recognizing the importance of the intellectual property rights regime in contributing to a more effective AIDS response, ensure that intellectual property rights provisions in trade agreements do not undermine these existing flexibilities, as confirmed in the Doha Declaration on the TRIPS Agreement and Public Health, and call for early acceptance of the amendment to article 31 of the TRIPS Agreement adopted by the General Council of the World Trade Organization in its decision of 6 December 2005;
 - b. Addressing barriers, regulations, policies and practices that prevent access to affordable HIV treatment by promoting generic competition in order to help to reduce costs associated with life-long chronic care and by encouraging all States to apply measures and procedures for enforcing intellectual property rights in such a manner as to avoid creating barriers to the legitimate trade in medicines, and to provide for safeguards against the abuse of such measures and procedures;

and present it to the Programme Coordinating Board in 2015 for its consideration.

Bureau members agreed that this is an important discussion which would require time to prepare, as well as broad consultations. The Bureau decided that these decision points would be addressed at a PCB meeting in 2016.

- [Gap analysis on paediatric HIV treatment, care and support]

Decision point 8.6 from the 35th PCB meeting: Requests UNAIDS to gather evidence and analyze the effects of stigma, discrimination and structural barriers on mothers' and

children's health, and the need for psycho-social support for children and affected families, in partnership with children and adolescents living with HIV and their caregivers; and to report back at a future Programme Coordinating Board.

Decision point 8.9 from the 35th PCB meeting: Requests UNAIDS to provide to a future PCB an updated gap analysis on paediatric HIV prevention, treatment, care and support.

The Bureau agreed that follow-up to the report presented to the PCB in December 2014 would be considered by the PCB in 2016.

- Decision point 8.8 from the 35th PCB meeting: Requests UNAIDS to provide regular reporting through the UBRAF on concrete actions taken and progress made by countries towards reaching the 90-90-90 targets for children.

The Secretariat informed the Bureau that reporting on progress on treatment for children was fully integrated into the UBRAF reporting, and would continue to be in the new UBRAF 2016-2021.

[Update on actions to reduce stigma and discrimination in all its forms]
Decision point from the 35th PCB meeting: Requests the Joint Programme to support
Member States and civil society in accelerating efforts to ensure enabling legal and
social environments where everyone, including key populations and other
marginalized populations, can access HIV services; and provide a report at a future
meeting of the PCB.

The Bureau agreed that the UNAIDS strategy 2016-2021 will include a section on enabling legal and social environments to access HIV services. This would constitute a baseline for identifying gaps and technical support needs of countries for which UNAIDS would provide support and report back to the Board on actions in 2016 or 2017.

[Next PCB meetings]

Decision point 10.2 from the 35th PCB meeting: Requests the Programme Coordinating Board Bureau to take appropriate and timely steps to ensure that due process is followed in the call for themes for the 38th and 39th Programme Coordinating Board meeting.

The Bureau requested the Secretariat to send the call for proposal of themes in May and the Bureau would subsequently select the themes to be recommended to the PCB for the 38th and 39th PCB meetings at its meeting in September.

3. Update on UNAIDS Strategy 2016-2021

Ms Beagle indicated that the Missions to the UN in Geneva would shortly receive the following documents on the update of the Strategy:

- an update with the latest timeline for the consultations on UNAIDS Strategy 2016-2021;
- a revised table with outcomes of the consultations; and
- a discussion paper on the update and extension of the UNAIDS Strategy 2016-2021

Ms Beagle informed the Bureau of the conclusions on the update and extension of the UNAIDS Strategy 2016-2021 for Asia and Pacific which was held on 31 January.

Finally, Ms Beagle confirmed that the Global multistakeholder consultation will take place on 22-23 April in Geneva. A discussion paper summarizing the key outcomes from the regional consultations would be prepared by the Secretariat as a background paper for this meeting.

Ms Ouedraogo confirmed that all background papers on the update and extension of the UNAIDS Strategy 2016-2021 were developed in consultation with, and with inputs, from all Cosponsors.

4. Any other business

ECOSOC

Ms Beagle indicated that she will present the report of the Executive Director to ECOSOC on 8 April in New York. She explained that in light of recent reforms, the ECOSOC Coordination and Management segment, including the item on the Joint Programme, will now be held in New York.

The Chair informed the Bureau that the Chair and Vice-Chair, in consultation with their Missions in New York had suggested that the initial work on the draft resolution for the agenda item on the Joint Programme would take place in Geneva.

The Chair and the Vice-Chair would consult with Member States and in accordance with usual practice, jointly facilitate, through informal consultations, the development of a draft resolution.

Bureau members expressed support to the approach proposed by the Chair and Vice-Chair and requested that, with the support of the Secretariat, a timeline for the process of the development of the draft resolution on the Joint Programme through the debate at ECOSOC in New York in April be provided.
