

## Introduction

2022-2026 Unified Budget, Results and Accountability Framework (UBRAF) is the strategic framework for the contribution of the Joint United Nations Programme on HIV/AIDS (UNAIDS) to the implementation of the Global AIDS Strategy 2021–2026


- overall strategic directions and expected results of the Joint Programme

## Specific Joint Programme outputs 2024–2025

- 1.1 Support countries in development and implementation of national policies, plans and road maps for combination HIV prevention with a focus on key populations and other groups at high risk of HIV infection.
- 1.2 Enhance national capacity for effective stewardship of HIV prevention responses for key populations and other priority populations, including key functions of analysis, prevention programme design, implementation, monitoring and accountability for impact.

### Milestones by end of 2025

- 1.1.1 80 countries supported in improving prevention policy and strategy for epidemiologically relevant key and priority populations
- 1.2.1: 80 countries receive technical and/or implementation support to scale up combination HIV prevention programmes by 2025, including 40 for implementing and monitoring of national prevention road maps

- Priority Actions: for example, address persistent gaps in key populations' access to HIV prevention by addressing underlying obstacles in relation to policy, structural barriers, financing and limited scale of programmes.
- Key partnerships: for example, countries, communities (including networks of people living with HIV, key populations, youth, women, civil society), partners, Global Prevention Coalition, Education Plus, FP2030...



Empowered communities have the capacities to exert leadership and take action in addressing the needs of people living with, at risk of or affected by HIV, especially to those who are currently excluded.

## Specific Joint Programme outputs 2024–2025

- 4.1 Promote normative guidance, with communities, for community-led responses with a focus on network strengthening, community-led monitoring and service delivery
- 4.2 Advocacy and technical support to countries for the incorporation and expansion of community-led responses (GIPA and engagement in decision-making, advocacy, service delivery and monitoring) in national HIV responses.

### Milestones by end of 2025

- 4.1.1 In at least 65 countries, technical support and guidance for community-led organizations from at least three of the most significantly affected communities in the country
- 4.2.1 In at least 65 countries, technical support to national and/or subnational governments and other stakeholders in the areas of community-led HIV advocacy, monitoring and research, service delivery, community engagement in HIV-related decision-making



**Priority Actions:** for example, to advocate for better government recognition and sustainable funding for community-led response and support community preparedness and policy guidance for social contracting for HIV services.

#### **EASTERN AND SOUTHERN AFRICA PRIORITIES 2024–2025**

#### **UBRAF Outcome 1**

- Combination HIV prevention for key and priority population well included in national HIV strategies or policies
- 10 countries supported to put into action and monitor 2025 Global HIV Prevention Coalition Road Map.
- PrEP scale up for key populations in 14 countries.
- Differentiated service delivery scaled up and sustained to reach population and location left behind especially to meet testing and treatment targets.
- EMCT certification maintained in Botswana and newly achieved in Namibia, Eswatini, Malawi and Rwanda and other front-runner countries.
- 8 countries part of the Global Alliance to end AIDS in children supported for action plans implementation & achievement of agreed targets.

#### **UBRAF Outcome 2**

- Community-led monitoring programmes implemented in 16 countries through direct support for implementation and cross-country learning.
- Expansion of community-led responses through support for optimized use of Global Fund grants, PEPFAR grants and domestic resources.
- Mitigation of the impact of criminalization laws and/or actions to repeal criminalization laws, in particular for key populations
- Step-wise approach or essential services package for strengthened HIV prevention across adolescent girls and young women
- Gender-sensitive HIV response in 4 countries through inclusion of gender assessment findings in the national strategic plans.
- Strengthened male engagement in gender and HIV and AIDS in four countries.

#### **UBRAF Outcome 3**

- Enhanced collaboration and coordination on HIV in humanitarian settings for tangible outcomes specially for migrant, adolescent girls and young women, key populations and people with disabilities
- Systematic collection, analysis and use of data on HIV in humanitarian settings to improve access to HIV services and protection

**Key partnership for results in the region:** with countries, communities (including country and regional networks of people living with HIV, key populations, youth, women) and other civil society and partners (including PEPFAR and the Global Fund, African Union, Southern African Development Community, parliamentary forums etc.) and others.






## **Joint Programme Indicators**

- Looking forward with, where needed, some revised 2025 milestones and 2026 targets informed by 2022 comprehensive progress report and noting initial set was developed to the best of knowledge but (over)cautiously during COVID-19 pandemic and informed by relatively small sample

# Secretariat Function on leadership, advocacy and communication – Indicator example

**Specific output** on sustaining and enhancing political commitments to end AIDS and implement the Global AIDS Strategy and end HIV-related inequalities.

**UBRAF Indicator**: Number of countries where the Joint Programme operates, that are supported to review, assess and/or update the National Strategic Plan on HIV (or equivalent) (S1.1.2)



**2022 Progress:** 83 countries where the Joint Programme operated were supported by the Joint Programme, with multidisciplinary technical expertise and peer review in over 30 countries. Based on the progress the 2025 milestone and 2026 target were carefully updated to reflect insights from the 2022 reporting noting most of the NSP are updated in 2022-2023 given more demand to inform Global Fund grants, usually cover 5 years with thus less NSP review/updated expected by 2025 and 2026.



   Cosponsors US\$ 64 million and US\$ 146 million for the Secretariat










# Key messages



## Key messages


- Next 2 years are crucial for the global AIDS response.
- Collaborative action and unique role of the Joint Programme is a central leading force for tangible results to reach the global AIDS targets.
- Clear strategic plan with specific outputs, outcomes, milestones and targets, guiding the regions, countries and global level toward collective impact.
- Clear prioritization started and to be further operationalized during detailed workplanning at all levels, focus on:
  - Advancing the HIV prevention agenda
  - Accelerating access to HIV treatment and new technologies
  - Expanding community-led HIV responses
  - Promoting equitable financing and sustaining the HIV response

while ensuring the full protection of gender equality and human rights



## Key messages

- A fully funded Joint Programme (at US\$ 210 million core annually) is critical for achieving the global AIDS targets 2025 and of ending AIDS as a public health threat by 2030.
- Without a fully funded UBRAF, UNAIDS' ability to support countries and communities, and especially direct work civil society, policy changes including on gender and human rights and have adequate presence in critical countries where the rates of HIV infections and AIDS-related deaths are on the rise is compromised.
- The funds invested in the Joint Programme yield excellent value for money, are relatively modest compared to the projected total annual resource needs for the global HIV response but generate, and amplify, high-impact across the global AIDS response, save more lives and accelerate progress to reach the end of AIDS.
