Functions of the PCB Bureau (Modus Operandi)

The Programme Coordinating Board (PCB) Bureau is intended to maximize the effectiveness and efficiency of the PCB. Specifically, the PCB Bureau has the responsibility for coordinating the PCB's programme of work for the year, including:

- i. Facilitating the smooth and efficient functioning of PCB sessions;
- ii. Facilitating transparent decision-making at the PCB;
- iii. Preparing the PCB agenda, and recommending the allocation of time to, and the order of, discussion items;
- iv. Providing guidance on PCB documentation, as needed; and
- v. Carrying out additional functions as directed by the PCB.

PCB Bureau review of recommendations by Informal Task Team on UNAIDS funding situation

On 10 November 2022, the PCB reviewed the full array of Task Team recommendations and finalized its report to the PCB on options for full, sustainable funding of the UBRAF. See summary of Bureau meeting for more information.

The PCB Bureau has expressed its appreciation to the Task Team for its excellent work in advising on ways forward to close the UBRAF funding gap.



Summary of PCB Bureau discussions regarding the recommendations identified by the Informal Multistakeholder Task Team

The PCB Bureau endorsed the Task Team's recommendations, with certain nuances. These nuances are reflected the PCB Bureau's report to the PCB on UNAIDS funding situation: UNAIDS/PCB/51/22.23

Nuances adopted by the PCB Bureau include the following:

- Noting that some countries would have issues implementing Recommendation 3.4 as drafted ("Access Global Fund Technical Set Aside funding from donor countries").
- Requesting that the recommendation on matching funds not be limited to domestic funds but include all resources a country could mobilize from all sources.



Summary of PCB Bureau discussions regarding the recommendations identified by the Informal Multistakeholder Task Team

 Clarifying Recommendation 3.5 to indicate that, in lieu of direct transfer of funds from the Global Fund to UNAIDS, consideration should be given to updating the Global Fund-UNAIDS MOU to allow for funding by the Global Fund of specific joint action plans or activity schedules.
