



- Peer review of policy by the evaluation offices of UNAIDS Cosponsors


# Key elements of UNAIDS evaluation policy

Responsibilities competencies and quality assurance




# Independence – a key aspect of evaluation

The UN Evaluation Group norms and standards identify behavioural and organizational independence as key aspects of evaluation

This requires an **evaluation office** that is:

- responsible for setting the evaluation agenda
- able to carry out evaluations without undue influence
- provided with adequate resources to conduct its work
- positioned independently from management functions

# Roles and responsibilities

#### **Programme Coordinating Board**

Approves the evaluation policy, plan and budget, considers annual reports on implementation and draws on evaluations for decisions

Appoints a geographically representative and gender balanced advisory committee and ensures required technical expertise

#### **Expert Advisory Committee**

An independent external body appointed by the Board which provides advice and guidance on the UNAIDS evaluation function

Consists of seven members, nominated by Member States (5), PCB NGO delegation (1) and Cosponsor evaluation offices (1)

# Roles and responsibilities – cont.

#### **Cosponsor Evaluation Group**

Brings together and leverages the resources of the Cosponsor evaluation offices for HIV-related evaluations

Promotes and advises on system-wide and joint evaluations related to HIV and serves as a reference for HIV-related evaluations

#### **UNAIDS Executive Director**

Fosters an enabling environment for evaluation, safeguards the integrity and independence and ensures follow up to evaluations

Ensures resources for evaluation, provides management oversight of the evaluation function and promotes a culture of learning

# Roles and responsibilities – cont.

#### **Evaluation Office**

Evaluates the work of the Joint Programme, i.e., the UNAIDS Secretariat and HIV-related activities of UNAIDS Cosponsors

A structurally and functionally independent unit with an overall budget corresponding to 1% of organizational expenditures

#### **Director of Evaluation**

Appointed by the EXD in consultation with the PCB Bureau; provides an independent report annually to the PCB.

- develops the evaluation policy, plans, guidance and tools
- manages evaluations and ensures use of findings and conclusions
- builds awareness, evaluation capacity and partnerships

# Next steps towards the 45<sup>th</sup> PCB meeting in December 2019

- 1. Establishment of an expert advisory committee on evaluation
  - PCB to nominate technical experts
- 2. Consultative process to develop evaluation plan for 2020-2021
  - to be approved by the PCB in December 2019
- 3. System-wide evaluation of the UN response to AIDS
  - i.e., evaluation of 2016-2021 Strategy and UBRAF
