

## Terms of Reference and proposed timeline for the Programme Coordinating Board (PCB) Working Group on the thematic segment of the 44<sup>th</sup> PCB meeting (27 June 2018)

#### DELIVERING ON SDG3: STRENGTHENING AND INTEGRATING COMPREHENSIVE HIV RESPONSES INTO SUSTAINABLE HEALTH SYSTEMS FOR UNIVERSAL HEALTH COVERAGE (UHC)

### I. Overview

At its 43<sup>rd</sup> meeting, the UNAIDS Programme Coordinating Board (PCB) agreed that the topic of the thematic segment of the 44<sup>th</sup> meeting would be *"Delivering on SDG3: Strengthening and integrating comprehensive HIV responses into sustainable health systems for Universal Health Coverage (UHC)"*.

A PCB Thematic Segment will provide PCB members an opportunity to:

- review evidence and options for integrating comprehensive HIV responses into Universal Health Coverage;
- to discuss lessons learnt from the HIV response in engaging civil societies and communities, addressing social determinants, including stigma and discrimination, and in promoting equitable access to services; and
- to identify priority approaches and areas of action for the Joint Programme to support countries, in consideration of the comparative advantages of the Joint Programme.

### II. Convening of PCB Working Group

UNAIDS Secretariat will convene a PCB Working Group (WG) to provide support and guide the development of the Thematic Segment. In particular, it is expected that the Working Group will provide technical and strategic inputs and advice on:

- (1) The development of the background note of the 44<sup>th</sup> PCB thematic segment;
- (2) The call for submission of country best practices, including advice on the criteria to use when selecting case studies to inform the background note and the agenda of the day;
- (3) The development of the agenda and format of the thematic day;
- (4) Possible speakers for the day.

### III. Operations of the PCB Working Group
